2015-15 Livable Communities Act Tax Base Revitalization Account (TBRA) Grant Recommendations Senior Planner Marcus Martin presented the report to the Community Development Committee.

It was moved by Elkins, seconded by Wulff, that the Metropolitan Council (1) award thirteen 13 Tax Base Revitalization Account grants as follows and (2) authorize its Community Development Division Director to execute the grant agreements on behalf of the Council:

2015-16 Public Hearing Report and Adoption of the 2040 Regional Parks Policy Plan

Planning Analyst Jan Youngquist and Research Analyst Raintry Salk presented the report to the Committee.

It was moved by Rummel, seconded by Wulff, that the Metropolitan Council:

- Accept the public hearing report on the 2040 Regional Parks Policy Plan
- Adopt the 2040 Regional Parks Policy Plan as part of the comprehensive development guide for the metropolitan area authorized under Minnesota Statues sections 473.145, superseding and replacing any park policies adopted by the Council prior to May 28, 2014 adoption of *Thrive* MSP 2040.

Motion carried.

Committee Members complimented staff for their work addressing equity and the focus on regional park use among people of color, particularly in light of changing demographics. Chair Cunningham also complimented staff for their due diligence to ensure the community was involved throughout the planning process. Chair Cunningham asked whether changes had been made based on recommendations received during the public hearing process. Staff stated clarity and additional language was added to the plan based on comments received.

2015-17 City of Inver Grove Heights Blackstone Comprehensive Plan Amendment, Review File No. 20614-8

Planning Analyst Patrick Boylan reviewed the City's proposal to the Committee.

It was moved by Chávez, seconded by Wulff, that the Metropolitan Council:

- 1. Adopt the attached review record and allow the City of Inver Grove Heights to put *Blackstone* comprehensive plan amendment (CPA) into effect.
- 2. Find that the CPA does not change the City's forecasts.
- 3. Advise the City to implement the comments in the Review Record for Aviation, Regional Parks and Trails, and Surface Water Management.

Motion carried.

Chair Cunningham asked if the amendment would affect affordable housing. Boylan replied that there was enough land in the City guided at densities high enough to allow the market to develop affordable units.
