  - Carlson reported on Metro Mobility ridership numbers, and reminded Council Members of the Transportation Committee location change back to Minneapolis.

  - Kandaras reported on the Safety and Security Action Plan and the Transit Rider Investment Program.

#### **Non-consent business**

 2024-152: Joint Powers Agreement with the City of New Hope (New Hope Police Department) Contract #24I027 (Captain Joseph Dothseth 612-349-7200)

It was moved by Cameron, seconded by Morales, that the Metropolitan Council ("Council") authorize the Regional Administrator to execute a Joint Powers Agreement ("JPA") # 24I027 with the City of New Hope.

Cameron asked for details on emergency calls and the impetus for the recent contract.

Motion carried. Hearing no objection, Vice Chair Chamblis stated the item could go Consent to Council.

2. 2024-162 SW: METRO Blue Line Extension - Authorize SDEIS Public Hearings (Nick Thompson 612-349-7507, Kelcie Young 612-373-3886)

It was moved by Morales, seconded by Carter, Toni, that the Metropolitan Council authorize scheduling and conducting public hearings for the METRO Blue Line Extension (BLE) Supplemental Draft Environmental Impact Statement (SDEIS) on July 16, 2024, from 5 to 7 p.m. at NorthPoint Conference Center, 1256 Penn Avenue North, Suite 5200, in Minneapolis and on Tuesday, July 23 from 10 a.m. to noon at the Brooklyn Park Library, 8500 West Broadway Avenue in Brooklyn Park.

Council Members asked for budget specifics and details on planning efforts.

#### Motion carried.

3. 2024-163: Procurement of 73 Biodiesel Forty-Foot Transit Buses, Contract 19P122E (Jeremiah Riter 612-349-500)

It was moved by Carter, Toni, seconded by Morales, that the Metropolitan Council authorize the Regional Administrator to negotiate and execute contract 19P122E with Gillig LLC to purchase (73) 40-foot buses for the Council's regular route services in an amount not to exceed \$62.982.481.

There were no questions or comment from Council Members.

4. 2024-164: Student Pass Agreement between Metropolitan Council and Special School District No. 1, Minneapolis Public Schools, Contract 24R003-03 (Dustin Crescini 612-349-7718)

It was moved by Morales, seconded by Carter, Tyronne, that the Metropolitan Council authorize the Regional Administrator to:

Enter into and execute a new 5-year Student Pass Agreement with the Special School District No. 1, Minneapolis Public Schools beginning August 1, 2024 to June 30, 2029 to provide Student Passes to eligible Students.

Council Members asked clarifying questions and requested follow-up.

Motion carried. Hearing no objection, Vice Chair Chamblis stated the item could go Consent to Council.

5. 2024-134: Amendment #1 with North Central Bus Contract 23P238 Metro Mobility Buses (Paul Colton 651-602-1668)

It was moved by Morales, seconded by Carter, Tyronne, that the Metropolitan Council

authorizes the Regional Administrator to execute an amendment to contract 23P238 with North Central Bus to increase the number of buses purchased from 16 to 197 increasing the contract by \$28,638,764 for a cumulative not to exceed amount of \$31,117,724.

There were no questions or comments from Council Members.

#### Motion carried.

6. 2024-135: Amendment #1 with Hoglund Bus, Contract 23P239 MTS Small Buses (Paul Colton 651-602-1668)

It was moved by Morales, seconded by Carter, Toni, that the Metropolitan Council authorize the Regional Administrator to execute an amendment to contract 23P239 with Hoglund Bus to increase the number of buses purchased from 23 to 163, increasing the contract by \$21,143,001 for a cumulative not to exceed amount of \$25,417,817.

Chamblis asked about procurement process estimated timelines. Colton shared the goal is the end of 2025 to have the fleet replaced.

7. 2024-155: Release of Restrictive Covenant and Quit Claim Deed for Apple Valley Gaslight Station (Heather Giesel, 651-602-1715)

It was moved by Morales, seconded by Carter, Tyronne, that the Metropolitan Council authorize the Regional Administrator to execute a Release of Restrictive Covenant and Quit Claim Deed for the Apple Valley Gaslight Station and its associated real property.

Carter, Toni, asked for additional context.

Motion carried. Hearing no objection, Vice Chair Chamblis stated the item could go Consent to Council.

8. 2024-156: Highway Harms Study Contract (Bethany Brandt-Sargent 651-602-1725)

It was moved by Carter, Toni, seconded by Morales, that the Metropolitan Council authorize the Regional Administrator to negotiate and execute contract 23P207 with Bolton & Menk, Inc. for consulting services for the Highway System Harms Study in an amount not to exceed \$980,000.

Chamblis voiced appreciation for the study.

Motion carried. Hearing no objection, Vice Chair Chamblis stated the item could go Consent to Council.

Council Members asked for details and clarification on the Regional Solicitation. Peterson explained the process of overprogramming.
