1. Disparities people with disabilities face in society (David Fenley, Minnesota Council on Disability and Chair of TAAC, 651-587-3899 and Ken Rodgers, TAAC Member)

David Fenley and Ken Rodgers had a conversation with council members about disparities people with disabilities face in society. They asked, each Council Member to state their district and what they would like to learn from this discussion. They discussed how this is complex work and all resources should be used, the difference between equality and equity, building awareness and get different perspectives, provided examples of times they've had issues with policies in the past, what the Council can do to serve all constituents, inclusion, and Connect 700 program.

Council members expressed gratitude for the conversation and information shared. They had comments and questions around accessible virtual meeting platforms, improvements and changes the Council can make, challenges COVID imposed on people with disabilities, request to revisit Metro Mobility Task Force and continue the conversation at TAAC and Transportation Committee level.
