## **INFORMATION**

Fifth Annual Placemaking Residency: Design for Equity

Mark VanderSchaaf provided an introduction and explained that "placemaking" is mixed land uses, the incorporation of public spaces sensitive to user's needs and aspirations, connectivity, and high quality, inviting urban design. Creative placemaking incorporates arts and culture, and deep placemaking incorporates arts and culture and personality. In 2011, the Council partnered with the McKnight Foundation to sponsor a Corridors of Opportunity workshop called "Unleashing the Potential of the Central Corridor." In 2012, the First Annual Placemaking Residency with Charles Landry occurred. Jodi Petrich from the Saint Paul Riverfront Corporation gave an overview of past Placemaking Residencies and described what is planned for this year's event. The Saint Paul Riverfront Corporation produces the Placemaking Residency, which is intended to inspire conversation about the future of our communities, build stronger networks among people who care about our cities, and realize the potential of and strengthen the Twin Cities as a world-class region. This year's theme is Design for Equity. The intended outcomes for this year's event are: a greater understanding of the implications of public and private development decisions and their impact on creating equitable environments; for community leaders to become committed to and be champions for putting equity into practice in the development of the greater MSP region; build stronger networks among people who care about our cities – from grassroots to grass tops; to learn how we as conveners can better support this network of leaders beyond the residency; and ultimately, change cultural norms and applied practice with respect to local governance. Petrich encouraged everyone to attend the events throughout the series.

## Metro Transit Everyday Equity Update

Wanda Kirkpatrick provided an introduction. Change Teams focusing on equity have been established in the five areas within the Council, and the Project Manager for the Metro Transit division is Allison Bell. Allison Bell, Gary Courtney (Metro Transit Technician Program Administrator), and Caitlin Schwartz (Community Outreach Coordinator) provided an update on some of the Everyday Equity activities going on at Metro Transit. Everyday Equity enhances the way we do business to create equitable outcomes. There are 12 employees on the Metro Transit Change Team, which is the coordinating body for the equity work within Metro Transit. The Team is working to build a network and share the equity concept among all employees. One of the ways Metro Transit is working to advance equity is by breaking down barriers to opportunity for community members, employees, and customers. Three examples of how this work is being done are employee engagement, the Metro Transit Technician Program, and the Better Bus Stops project. The Metro Transit Technician program is an innovative career development program designed to address Metro Transit's current and future Bus Mechanic Technician needs through a sustainable workforce pipeline. The goals of the Better Bus Stops project are to improve bus stops that enhance access to employment, education, and opportunity, and have authentic community engagement.

Metro Cities held an information session on the new Regional Solicitation and 35 communities were represented; a few of the TAB citizen members also attended.

Participated in the Community Development Conversations Series at the History Center where he spoke about housing and community development issues in the region. CM Dorfman also attended. Participated in a tour and train ride with Karlis Barobs, an 8 year-old boy with cancer who wanted to donate some of his cancer funds to SWLRT. Attended an equity event at the MCES Metro Plant along with CM Rummel.
