A quorum being present, Council Chair Zelle called the regular meeting of the Metropolitan Council to order at 4:00 p.m.

Information

1. Report on Thrive MSP 2040 Equity Commitments

Lisa Barajas, Director of Community Development, presented the Thrive MSP 2040 progress on Equity Commitments and shared the highlights of the actions that the Council has taken since 2014 to implement each of the commitments under Equity. Barajas talked about the purpose, scope of the report, and the five outcomes: Sustainability, Prosperity, Equity, Livability, and Stewardship. She also provided takeaways applying to the 2050 Regional Development Guide.

Council Member Barber stated it's important to continue engagement and reach out to communities. Council Member Chamblis said the takeaways are important, and she's happy to see systems for making tracking easier were included and standardizing the tracking would be helpful. Council Member Gonzalez had questions about tracking and asked if there are criteria for communities that need assistance with planning. Barajas stated this is a project they will be working on gentrification and all things related to Council investments. Council Member Vento asked if past council members had a role in conversations with local governments and if it will be a part of the 2050 Regional Development Guide process. Barajas stated they encourage council members to have engagement and partnerships with policymakers. Council Member Wulff said it is important to continue training and communication with cities and counties. Wulff also had a question regarding streamlining comprehensive plans and resources for smaller local governments. Chair Zelle stated this could save staff time and money, and it's a benefit if we can meet townships or cities where they are. Council Member Johnson had questions about the process, timeline, and branding. Barajas stated we are looking at ways to make the document easier to read and navigate. Council Member Sterner asked if counties help townships and smaller cities with planning. Baraias stated there are a few counties that assist with planning.

Council Member Fredson reminded everyone it's workers memorial week and thanked the frontline workers.

Deputy Regional Administrator Georges Gonzalez introduced himself and stated staff are back in the office in hybrid model.
