## Dakota Land, Water, and People Acknowledgment

The Metropolitan Council acknowledges that the land we currently call Minnesota and specifically the seven-county region is the ancestral homeland of the Dakota Oyate who are present and active contributors to our thriving region. As part of the Metropolitan Council's commitment to address the unresolved legacy of genocide, dispossession, and settler colonialism and the fact that government institutions, including the Metropolitan Council, benefitted economically, politically, and institutionally after the forceable removal of the Dakota Oyate, the Metropolitan Council is dedicated to instilling Land, Water, and People Commitments in regional policy. These commitments support the Dakota Oyate, the eleven federally recognized Tribes in Minnesota, Ho-Chunk Nation, and the American Indian Communities representing over 150 diverse Tribal Nations that call the seven-county region home.

## Call to order

A quorum being present, Committee Chair Hovland called the regular meeting of the Transportation Advisory Board to order at 12:32 p.m.

## Reports

1. TAB Chair’s Report – Jim Hovland

Chair Hovland reported that on the federal level reconciliation is going on and looking forward to transportation reauthorization bill in September 2026. Currently there is review of the federal funding that may have some impact of DEI upcoming in trunk highway funds (formula funds).

Agency Reports – MnDOT, MPCA, MAC, Metropolitan Council, Suburban Transit Association  
MnDOT

Sahebjam reported on safety updates; in the metro area, there were 42 fatalities at the end of April (10 pedestrian, 4 motorcycle, and 1 bicycle). Statewide there were 115 fatalities as of May 20. This is down from 138 fatalities in 2024 at the same time. Sahebjam reported on changes on the federal level. There used to be DEI on the federal level and now it is just on the state level. Documents sent to the federal government follow the federal process. FHWA staff in Minnesota has been cut in half. Minnesota FHWA director is now overseeing North Dakota and South Dakota as well.

MPCA

There was no MPCA report.

MAC

There was no MAC report.

Metropolitan Council

Chamblis reported that Metro Transit will be launching the B Line on June 14. The B Line runs between Minneapolis and St. Paul along Lake Street and Selby Avenue. B-Line Opening Activities include the ribbon cutting at Union Depot. Other transit service improvements will also go into effect on June 14.

Suburban Transit Association

Hansen reported: Maple Grove Transit reported growth in ridership, mainly Tuesday through Thursday. University of Minnesota ridership is strong and consistent. Microtransit ridership is growing and much of Maple Grove Transit’s capacity is maxed out due to demand for these rides. Maple Grove Transit and Plymouth Metrolink expect that final reports on their joint transit needs assessment study should be available by mid-July. SouthWest Transit’s 494 corridor service, Route 686, is fully operational, and their new autonomous vehicle service has booked about 1,600 rides since launching on April 15. Minnesota Valley Transit Authority Connect microtransit ridership is up 45% year-to-date, but continued expansion is challenged due to funding uncertainty. MVTA will offer expanded hours for its State Fair service, beginning two hours earlier at 7:00 A.M. from Eagan and Shakopee.

2. TAC Report – Joe MacPherson, TAC Chair

1. Blue Line Extension and Gold Line Extension Transitway Project Updates (Nick Thompson, Metro Transit and Bradley Bobbitt, MTS Planning)

TAB members asked about station details, public engagement specifics, lessons learned from other projects, anti-displacement plans, and federal reimbursement.

2. Regional Solicitation Evaluation Update (Steve Peterson, MTS Planning)

TAB members commented on workshop details, incorporation of projects, and support of a hybrid structure. TAB members discussed current legislative proposals for project funding.

3. Regional Safety Action Plan (Heidi Schallberg, MTS Planning)

TAB members noted the intersection with local safety action plans, noted the need for tracking, geographical balance, data collection and formulation, information dissemination, and considering additional physical barriers. TAB members asked about the Regional High Injury Streets map and other maps.
