INFORMATION

Super Bowl LII Service Planning Update

Brian Lamb, Assistant Police Chief AJ Olson, Mark Benedict and Brian Funk provided an update on current service plans for Super Bowl LII. The Super Bowl is a top-tier national security event with a SEAR 1 rating; Metro Transit has coordinated with Homeland Security as well as other regional law enforcement partners for this event. There will be a secure perimeter around the stadium beginning February 2. The current service plan is for replacement buses on the Blue Line, a portion of the Green line on gameday, and direct stadium access for fans. U.S. Bank Stadium Station will close the evening of Friday, February 2. There will be free replacement bus rides for regular service customers with

departures every 10 minutes. Additional local and express bus service as well as extended Northstar service will be in effect from January 26—February 5th to accommodate the increase in ridership. The service plans as presented are current as of November 29 and are subject to change. Metro Transit is planning a "Know Before You Go" campaign, and ambassadors and host committee volunteers will also be available at transit stops to provide more information for customers. The Metro Transit "Trip Planner" will be programmed to include service changes during the Super Bowl service period and NexTrip will provide reroute details and up-to-date service information. Signage will also be posted at each bus stop and light rail stop that is re-routed. Metro Transit has been working with the Metropolitan Airports Commission (MAC) for airport operations and travel planners will be stationed at the airport to help with way-finding.

Human Trafficking Awareness Training

Christy Bailly and MTPD Officer Marc Johnson provided an update on Metro Transit efforts to curb human trafficking in the region. In 2013, representatives from the Ramsey County Attorney's Office, Carlson Companies, Women's Foundation of Minnesota along with St. Pail and Minneapolis Police Departments approached Metro Transit to begin a bus operator focus group. Police, supervisors and bus operators have been trained to recognize and report signs of human trafficking, and there is ongoing MTPD response from operator calls. Super Bowl LII is expected to increase instances of human trafficking with the influx of visitors in town. Metro Transit has begun a campaign similar to the "if you see something, say something" campaign; customers will be able to report trafficking through a 1-800 number or through a future "Text for Safety" method of reporting. General discussion included Council Members stressing the importance of a text-based emergency system as well. Both the Metro transit emergency app and emergency texting system will be rolled out together in advance of the Super Bowl.
