INFORMATION

1. Construction Procurement Process Overview

Members of the procurement team presented an information item that provided a high-level overview of the Council's Procurement department process and steps for the completion of a major construction solicitation.

Comments and Questions:

- Committee Member Sterner asked if an MCUB supplier or subcontractor that may support the project, is there someone on staff that the vendor could go through to inquire about the project. The Office of Equal Opportunity can be contacted if small businesses are interested. A meet and greet can be set up to learn more about the Council or to have them share information about themselves with the Council. Interested vendors may contact Elaine Ogilvie at Elaine.Ogilvie@metc.state.mn.us or via phone at 651-602-1163.
- Chair Lindstrom inquired about the engineers estimate. Are there rules if a bid comes in and is off of the estimate or is it handled on a case by case basis? Procurement stated the engineer's estimate is important, it is an independent estimate that gives everyone an idea if the prices are coming in as anticipated. Prices have not been predictable and there have been a number of public construction projects that we have seen bids come in higher than estimates. We can go up to 10% above the engineer's estimate and may have to obtain additional information/approvals. The bids need to be reasonable and responsive and within our cost estimates.
- Committee Member Wulff stated the process is set up to make things fair; there are a lot of people and steps that are involved in the process. Do we know how much this adds to the cost on a typical project? Procurement stated there are a number of variables that are taken into consideration. Some projects require additional documentation and more preparation. It may add approximately 10%.
- Committee Member Zeran stated in the construction industry, bidding jobs overhead is 10 to 15% of all the work done by the contractor.

2. General Manager Report
