### Water Resources Policy Plan Schedule Update

Judy Sventek, Manager of Water Resources Assessment, informed the committee that staff has developed the following schedule for briefings in 2013:

- Wastewater/wastewater system plan: January and February
- Water quality: March
- Water supply: April
- Water sustainability policy foundation: May
- Wastewater policy: June
- Water quality and water supply policy: July

Staff intends to finalize the policy plan will in August, and bring it to the committee in November to review. In December, the Committee-of-the-Whole will be asked to adopt the plan for the public hearing process. After some discussion, it was decided that staff will provide an update to the Council mid-2013.

Wastewater/wastewater system briefings will begin in January 2014.

### **General Manager's Report**

If all goes well, at the end of the month, an additional treatment plant will have achieved continuous compliance for five years and will receive a NACWA award next year.
