The Metropolitan Council is soliciting proposals for Master Contract for Water Sustainability Services, 24P275 to provide technical assistance to support the implementation of projects that address emerging threats to the drinking water supply; provide cost-effective regional solutions; leverage interjurisdictional coordination; support local implementation of water resources and water supply reliability projects; and support the growing needs of community water suppliers facing challenges.
