INFORMATION ITEM

1. METRO HRA Annual Public Housing Agency Plan (Terri Smith, 651-602-1187)

HRA Director Terri Smith presented the information to the Council.

Council Member Chamblis stated it's important to engage and communicate with the Equity Advisory Committee (EAC) and community and be created in how we address the issues with staff and voucher funding and limitations. Council Member Chamblis also had questions regarding the cycle of vouchers and distribution.

Council Member Vento expressed thanks to staff and suggested convening a region wide conversation.

Council Member Lilligren expressed thanks to the staff and council members and is supportive of the recommendations. He voiced not to put a number or percentage on Project Based Vouchers (PBV) and stated this is a complicated process, and the issue is we don't have enough production and have limited resources.

Council Member Johnson expressed gratitude for Terri Smith and staff and is excited about the program. She made comments regarding the projects on waiting list and gaps in funding and that we had additional project-based vouchers. She suggested going forward, hire more staff and look at combining the waiting list and Project Based Vouchers (PBV) list, and council members should reach out to Congressman.

Terri Smith clarified all vouchers are in use or cycled.

Council Member Atlas-Ingebretson supports the plan and appreciates Council Member Lilligren for bring this discussion forward to Council meeting. She would also value visual story telling of peoples experience and engagement.

Chair Zelle stated this is important and complicated issue.

Council Member Vento recommended two articles in the Sunday Tribune about the City of St. Paul and Ramsey Country efforts addressing housing last year and Counterpoint: Local housing solutions are best addressed by cities.

Chair Zelle praised staff who helped facilitate the subcommittee field hearing with Senator Smith and Federal Transit Administrator to talk about MN transportation.

General Counsel Ann Bloodhart reported they completed a two-week clerkship with Twin Cities Diversity and Practice and stated we are the only government entity involved. They have also been working with Just Deeds, and the team has completed training and will be matched with cities to do pro bono work.
