## **INFORMATION**

Overview of Riverview Locally Preferred Alternative and TPP Amendment

Cole Hiniker and Mike Rogers from the Ramsey County Regional Railroad Authority presented on the Riverview Corridor. The Riverview Corridor Study Area is a 12-mile area between St. Paul and Bloomington, and connects major destinations, neighborhoods, and jobs. An amendment to the TPP would add the Riverview Modern Streetcar LPA to the fiscally constrained plan. The Council is scheduled to adopt the 2040 TPP Update on October 24<sup>th</sup>, 2018.

2020 Census: Metropolitan Council's Partnership with the Census Bureau

Todd Graham and Andrew Virden from the Census Bureau presented on the 2020 census. The Council worked with the Census Bureau prior to 2010 to improve geographic data precision and has been providing advice to the Census Bureau through the Data Products Redesign Group and the State Data Center national board. A new digital platform will expand outreach opportunities, including an email campaign with a direct link to the 2020 Census response site. Virden encouraged everyone to fill out the form and help others fill out their form.

Transit Investment Report

Nick Thompson presented the Metropolitan Area Transit Investment Report. MN SS 473.4485 requires the report every even-numbered year and covers 10 years (2018-2028). Requirements and key elements of the report include capacity analysis (identify all funding sources and expenditures related to Metropolitan area transit), route performance (analyze the past three years for each existing mode and transit route in the region, and projects in operation, construction, or development.

2019 Capital Program

Mary Bogie began the presentation on the 2019 Capital Program, which is \$7.6B. Uses by department are as follows: Wastewater: 18%, Parks: 5%, Transit: 23%, Transitways: 54%. Ned Smith presented the Environmental Services portion, which has a capital program of \$1.34B. Nick Thompson and Ed Petrie presented on the Transit and Transitways portion, which has capital program of \$5.8B. Lisa Barajas presented on the Parks and Open Spaces portion, which has a capital program of \$375M.
