The Metropolitan Council(Council) is soliciting proposals for the following services: software to support microtransit service operations. Microtransit is a demand-responsive transit service where users request on-demand trips either using a mobile application or by calling a reservationist and trips are assigned to the next available vehicle for completion. The Metropolitan Council is developing a plan for implementing microtransit and this agreement will secure software to support that implementation. The software will provide an application for customers to schedule, monitor, and manage trips and driver and administrator interfaces to operate services.
