

## METROPOLITAN COUNCIL Advance Notice of Pre-Solicitation Meeting for Customer Issue Reporting and Tracking Project + Text for Safety Contract Number 25P148

The Metropolitan Council will be soliciting in the near future proposals for a Customer Issue Reporting and Tracking project. This project involves the procurement of a large-scale, multi-package software solution to support customer issue tracking and reporting, as well as a Text for Safety program.

The Council is holding a **Pre-Solicitation Meeting** to obtain information and input from the Vendors concerning an upcoming solicitation. At the Pre-Solicitation Meeting Council staff will provide an overview of the Council's proposed study. The goal of the Pre-Solicitation Meeting is to gain Vendor feedback concerning the current scope of work and to maximize engagement and Vendor participation in the future solicitation.
