Dakota Land, Water, and People Acknowledgment

The Metropolitan Council acknowledges that the land we currently call Minnesota and specifically the seven-county region is the ancestral homeland of the Dakota Oyate who are present and active contributors to our thriving region. As part of the Metropolitan Council's commitment to address the unresolved legacy of genocide, dispossession, and settler colonialism and the fact that government institutions, including the Metropolitan Council, benefitted economically, politically, and institutionally after the forceable removal of the Dakota Oyate, the Metropolitan Council is dedicated to instilling Land, Water, and People Commitments in regional policy. These commitments support the Dakota Oyate, the eleven federally recognized Tribes in Minnesota, Ho-Chunk Nation, and the American Indian Communities representing over 150 diverse Tribal Nations that call the seven-county region home.

Information

1. Legislative Updates (Judd Schetnan)

Judd Schetnan, Director of Government Affairs, began his presentation with appreciation for all staff and governmental partners who supported the Government Affairs work at the Capitol this session. The presenter also thanked the late Representative Melissa Hortman and shared that she was responsible for the Community Tree Planting grants approved in the consent agenda.

The presentation highlighted the 2025 legislative session noting it was a budget year, and provided a session overview including a high-level summary of the legacy omnibus bill which included the Clean Water Fund and the Parks & Trails Fund. The presenter provided highlights of the judiciary and public safety omnibus bill and the omnibus transportation bill. Presenter highlighted 2025 regular and special session outcomes regarding funding including base general funding for Metro Mobility and Metro Move services, as well as Regional Transit Capital Bond authorization and the capital investment bill.

Council members appreciated the team for their work and thanked them for their leadership, and asked questions about a potential 2nd special session. Regional Administrator O'Connor praised the team for leaning in to make the region better together.

Reports

CM Pacheco appreciated the legacy of Lt. Beverly Rodriguez as an integral part of the HAT team and recognized her membership as a member of the National Latino Police Officers Association.

Chair Zelle shared his praise of the late Representative Melissa Hortman's bipartisan reach as an amazing last official act and noted tragedy doesn't dissolve the work.

Chair Zelle also shared that Governor Walz has appointed two new members of the Metropolitan Council to be sworn in at the July 9, 2025 regular meeting of the Metropolitan Council. Chair Zelle also shared gratitude for CM Vento's service as a council member and for her many other roles in the community.
