1. Information Item: Network Next Arterial BRT Evaluation Results (Katie Roth, 612-349-7772; Kyle O'Donnell Burrows 612-349-7749)

Katie Roth, Assistant Director of BRT Projects provided an introduction on Network Next a 20year plan with priorities for implementation, four principles guide Network Next planning, 10 promising corridors, current riders served by planned and potential arterial BRT corridors pre-COVID and during COVID, investment in connectivity and accessibility. Kyle O'Donnell Burrows, Senior Planner, BRT Projects presented on Arterial BRT Corridor development process, 19 initial corridors identified, quantitative screening criteria, engagement and what was heard, evaluation criteria and results, corridor readiness review and evaluation, corridors by tier and next steps.

Council member Barber thanked Katie, Kyle and the team for their work and mentioned the importance to continue moving the ABRT program forward. Council member Lindstrom asked if regional parks and other amenities had a role in the valuation criteria and requested the top 10 routes for ridership in the region. Council member Cummings commented on the importance of a robust system and request Metro Transit to share materials with council members to help promote Network Next and the prioritization of potential new BRT routes. Council member Chamblis asked questions regarding scoring criteria. Council member Johnson reminded staff to think about achieving the Council goals. Council member Lee thanked staff for great presentation.

2. Information Item: Southwest LRT Project Update (Jim Alexander, 612-373-3880)

Jim Alexander, Assistant General Manager began the presentation with a Southwest LRT (SWLRT) Project update including overall project, civil construction update, real estate acquisition and relocation status. Jon Tao, EO Consultant provided an update on the DBE and Workforce including Equity Commitments to the Region, DBE Achievements as of September 30, 2020, Civil Contract DBE disaggregated, civil workforce participation percentage and cumulative, LMJV workforce good faith efforts, and the December 1 DBE check-in visits. Sam O'Connell, Senior Manager, Public Affairs provided an update on construction outreach and communications.

Council member Atlas-Ingebretson requested disaggregated workforce data for POCI. Cummings asked for the statue of the project timeline. Council member Barber thanked staff for their work and the updates.
